INDIAN INSTITUTE OF MANAGEMENT CALCUTTA TWENTY-EIGHTH ANNUAL REPORT (April 1, 1989 to March 31, 1990)

1. THE INSTITUTE

The Indian Institute of Management Calcutta (IIMC) was the first national Institute established by the Government of India in 1961 to spearhead professional management in Indian industry, business and government. Co-operating with the Government of India in this effort were the Alfred P. Sloan School of Management of Massachusetts Institute of Technology, the Government of West Bengal, the Ford Foundation and the business community. It now forms an integral part of the Government of India's efforts to promote professional management in India. IIMC moved into its 29th year on November 14, 1989. During this period it has grown from strength to strength and is today playing a major role in the task of improving management practices in India. More than 2000 alumni are in positions of strategic importance in industry today - in India as well as abroad. In addition, a large number of senior managers from Indian industry and Government have had the benefit of interaction with IIMC through its Executive Development Programmes, Extension Programmes and Consultancy assignments. The Institute attaches great importance to research which is devoted to problems of management and those of development. Indeed, management of development is a major focus of the Institute's range of activities.

One more year of fruitful activities has been completed, which incidentally is the 5th year of the Seventh Five Year Plan (1985-90). The Institute continued to focus its research and training activities on Public Enterprises, Project Management and Environment Management for which separate activity centres exist. Another area in which the Institute has been working and will continue its endeavour with greater emphasis is in the use of computers for solving management problems. Information on the different activities of the Institute and the efforts it has continued to make to ensure the maintenance of high standards of performance are provided in this report.

2. SOCIETY AND THE BOARD OF GOVERNORS

The Institute was constituted on November 14, 1961 as a Society under the Societies' Registration Act. It is administered by a Board of Governors. The Chairman of the Board is appointed by the Government of India in consultation with the Government of West Bengal. Other members of the Board include nominees of the Central and State Governments, representatives from constituencies like education, commerce, industry, labour and other interests. The Director of the Institute and two nominees of the Institute's Faculty are also members of the Board of Governors. A substantial part of the annual recurring and non-recurring expenses of the Institute is provided by the Government of India.

A list of members of the Society and the Board of Governors during the year 1989-90 (as on March 31, 1990) is given in Annexure I.

3. OBJECTIVES OF THE INSTITUTE

The objectives of the Institute are:

- * To direct the education and development of young men and women along specific lines so as to match the management needs of industrial and other types of organizations.
- * To establish an infrastructure which would provide practising managers with the opportunity to acquaint themselves with management concepts, techniques and research.
- * To establish a rapport between management scientists and industrial decision-makers through consultancy and training programmes aimed at facilitating problem solving in organization.
- * To build a Centre of Advanced Management providing opportunities for innovative research and promoting the development of indigenous literature on management.

Since its establishment, the Institute has been channelizing all efforts and resources to accomplish its objectives through the following programmes.

A.1. POST GRADUATE PROGRAMME IN MANAGEMENT

The two-year Post Graduate Programme in Management is a full-time residential course for graduates from all disciplines. The 26th session of the Programme began in July 1989 with 179 students from all over the country in the First Year and 138 students in the Second Year. The number of the Scheduled Caste and Scheduled Tribe students in the First and Second Year were 31 and 22 respectively. There were a total of 20 girl students (including 2 S.C. and 1 S.T. students) in the First Year and 15 (including 2 S.C. and 1 S.T. students) in the Second Year. Although 179 students were admitted, in the first year, the strength came down subsequently to 158. This drop was caused by withdrawals during the middle of the programme.

The Post Graduate Programme (PGP) of the Institute is designed for students desiring to embark upon careers in management, who are willing and able to devote two complete academic years in pursuing studies in management education. Students from all over India continue to be attracted to the Programme. It is the core activity of the Institute designed to meet the challenges of rapid changes in our society. The students are continually encouraged to deal with unstructured situations and evolve solutions to complex problems. To provide a basis for this approach to learning, the First Year of the Programme is devoted to developing a working knowledge of Economic Principles, Principles of Organisation and Behaviour, Financial and Accounting Systems and Quantitative Methods for solution of management problems.

The academic year at the Institute is divided into three terms each consisting of about twelve working weeks. The Programme requires six terms of full-time work. Due to the nature of the learning process which requires a fulltime involvement rather than just the attendance in classes, the Programme is entirely residential. The students are continuously graded, not only on their performance in the examinations but also on class participation, home assignments, projects, presentations, etc. In the First Year, all the courses are compulsory. In the Second Year, the students are allowed a choice of 13 electives over three terms along with three compulsory courses. In the summer between the First and Second Year, the students are expected to gain practical experience through related employment. Apart from helping the students to supplement their academic knowledge through practical exposure, this aids them in their selection of Second Year electives.

The Institute's faculty use many different pedagogical tools to facilitate learning. The Institute believes that the method of instruction for maximising learning varies from course to course and so uses varying proportions of the case study method, lectures, group exercises and project work.

The students after completing the Diploma at the Institute have fairly exciting careers ahead. The period covering the next few years in our country will see rapid changes and the Institute's educational programme should take these into account in its courses. The teaching programmes of the Institute are, therefore, designed to help the students develop a base from which they continue to learn. The programme stresses conceptual and analytical reasoning while providing students with the knowledge of the current state of business and the decision models used by managers today.

More than 2000 young managers have graduated from the Institute and are oday occupying important positions.

A.1.(1) Admission

Students are admitted to the Post-Graduate Programme on the basis of their interests, aptitude and capacity for undergoing a rigorous programme of study in management sciences as indicated by previous academic records, scores in the admission test, performance in group discussions and interview, and also work experience.

The applicants should hold at least a Bachelor's degree in any field including arts, physical sciences, commerce, engineering and the social sciences, or professional diploma considered equivalent to a Bachelor's degree, with the following minimum requirements:

(i) 50% marks (45% for SC/ST candidates) in SSC or SSLC, High School, Higher Secondary or Senior Cambridge or Recognised School Terminal Examination of any Board/University. Where 10+2 system is followed candidates must have 50% marks (45% for SC/ST candidates) in aggregate in any one of the examinations either at the end of 10th year or at the end of the plus two phase;

and

(ii) 50% marks in aggregate (45% for SC/ST candidates) in Bachelor's degree.

One of the methods of judging the fitness of a candidate to the Programme is the Common Admission Test (CAT) administered jointly by Indian Institutes of Management at Ahmedabad, Bangalore, Calcutta and Lucknow.

A.1.(2) <u>26th Post-Graduate Programme (1989-91)</u>

A total of 10,560 candidates applied for admission to the 26th session of Post-Graduate Programme commencing in July 1989 including 418 Scheduled Caste and 123 Scheduled Tribe candidates. Annexure II gives the details for the last 5 years.

Out of the 10,560 applicants for admission, 1133 candidates were invited for personal interview by a panel consisting of faculty members of the Institute, experts from Industry and Government and alumni at different interview centres all over India. Out of the 1133 candidates selected for personal interview, 179 candidates belonged to SC/ST community (Annexure III). Ultimately after going through the selection procedure a total of 179 students were admitted to the 26th Post-Graduate Programme.

A.1.(3) Educational background of the selected students

A study of the educational background of the students selected for the 26th session (1989-91) reveals that 84.4% belonged to engineering stream and 15.6% belonged to non-engineering stream (Annexure IV).

A.1.(4) Reservation for SC/ST candidates

0

22.5% seats of the Post-Graduate Programme are reserved for candidates belonging to Scheduled Caste/Tribe community and some relaxation in entry standard was extended to them as in earlier years. A total of 541 applications for admission to the Programme (1989-91) was received from candidates belonging to SC/ST community. Out of this, 179 candidates were called for personal interview and finally 31 candidates joined the Post-Graduate Programme.

A.1.(5) 27th Post-Graduate Programme (1990-92)

The Common Admission Test for selecting students for the 27th session of Post-Graduate Programme (1990-92) commencing in July 1990 was held on 11th December 1989 all over India at 18 centres.

The six examination centres at (1) Bhubaneswar (2) Calcutta (3) Guwahati (4) Vijawayada (5) Nagpur and (6) Patna were controlled by IIMC.

The written admission test was common for IIM Ahmedabad, IIM Bangalore, IIM Lucknow and IIM Calcutta. The number of candidates appeared at the Common Admission Test was 18,183. A total of 8859 candidates submitted applications for admission to the Institute. Out of this, 398 candidates belonged to Scheduled Caste and 84 belonged to Scheduled Tribe community.

A.1.(6) <u>Curriculum</u>

For the Post-Graduate Programme, the principal fields of study include economics, statistics, operations research, behavioural sciences, sociology, history and law, economic, social and political environment of enterprises, applied fields of marketing, production, finance, personnel management, labour relations, materials management, information systems, management policy, organizational communication and decision-making, managerial accounting and control and regional development. In addition, the students are required to work on a project during the summer between the first and the second year of study. Summer Projects are meant for those students who have completed the First Year of the Post-Graduate Programme successfully. Each student is required, as a compulsory part of the curriculum, to spend about eight weeks of the period May - June working on a project specified by an employer and to submit a report to the sponsoring authority. The student works under the guidance of a faculty member who finally evaluates the project report. The summer project is assigned a weightage equivalent to that of one course in the curriculum. A list of Organizations where the Post-Graduate Programme students worked for their Summer Project in May-June 1989 is given in Annexure IV(A).

In the Second Year, for interested students, specialization packages are available in two streams, viz. (i) Development Studies and (ii) Systems and Operations Management. The courses, Indian Legal System, Management Policy and Management Game are compulsory for the Second Year students. The list of optional courses offered in the Post-Graduate Programme (under review) are shown in Annexure V.

During the academic year 1989-90, the different academic groups announced 22 compulsory courses and 68 optional/elective courses (26 in Term IV, 28 in Term V and 14 in Term VI) in various disciplines and areas.

A.1.(8) Financial Assistance, Scholarship and Prizes

The Institute provides financial assistance to more than 25% of the students enrolled in the Post-Graduate Programme every year. The assis-tance comes mainly from two sources: Government of India funds (on merit-cum-means basis) and scholarships awarded by Companies and Trusts. The Government assistance is of the value of Rs. 1,700/- per annum in addition to full remission of tuition fees for the year. Besides, meritorious students studying in the Second Year work as tutors for First Year students and are paid a stipend.

Each Scheduled Caste/Scheduled Tribe student admitted to the Programme is eligible for a stipend of Rs. 1,700/- per annum besides waiver of tuition fees and accommodation charges.

A.1.(9) System of Evaluation

Students are evaluated on the basis of examinations, reports, take home assignments, term papers, class performance, seminars, regular tests, surprise quizzes and oral examinations as determined by the faculty member concerned. Sometimes, in courses involving group methods of teaching, students play a major role in grading each other.

A.1.(10) The Passing Standard and the Diploma

Marks under the grade-point system are used in evaluating a student's performance in each term and in the two-year Programme as a whole.

To graduate, a student must obtain an average of at least 5.0 in all courses, taken on credit in the Post-Graduate Programme. Generally, in order to be

promoted to the Second Year, a student should obtain an average of at least 4.5 at the end of the third term. A student who achieves an average of less than 4.5 at the end of the third term may sometimes be permitted to continue, subject to satisfactory fulfillment of conditions stipulated by the Faculty according to the merits of the case. However, a student once admitted must fulfil all requirements for the Diploma within three academic years.

Those who successfully complete the two-year Programme are awarded the Post-Graduate Diploma in Management (PGDM), which has been recognised as equivalent to a Master's degree in Business Adminis-tration by the Ministry of Education, Government of India, by the Associa-tion of Indian Universities (formerly the Inter-University Board of India and Ceylon) and foreign Universities who have admitted our students into their doctoral programmes.

A.1.(11) Students' Participation

IIMC has been in the forefront in allowing students participation in activities which are student related. Elected student representatives sit on the PGP Committee, Fellow Programme Committee, Placement Committee, Library Committee etc. along with faculty and administration and help to decide on vital policy matters.

Students elect their representatives for colloquia, magazine, games and social activities. Every student is a member of the Students' Association, which has a President, General Secretary and Treasurer. Students run their own Mess and sometimes raise resources for their activities and programmes.

A.1.(12) Placement

The Placement Programme of 1989-90 was excellent, both in terms of the quality of jobs offered as well as the speed with which the students were placed. All the students were placed within exactly 12 active Placement days. Most of the students secured the kind of jobs they wanted and the level of satisfaction on part of the students as well as the recruiting organisation was high.

Some of the highlights of the placement programme were:

- A total of 164 offers were made to a batch of 131 students who sought placement services. These offers were made by 57 visiting companies. 45 of these were in private sector and 12 were in public sector.
- There was a good spread of students over various types of organisations. This year 29 students or 22% of the total batch joined the public sector, which is comparable to 34 or 23% who joined public sector in 1989. Details of the placement, sectorwise and on the basis of nature of jobs, during the last 5 years are given in Annexure VII. Another important feature is that the students from Scheduled Caste/Tribes were also placed in very good jobs. The same had been the case with students who are completing the PGDM in three years. It was heartening to note that of the 22 SC/ST candidates, 19 found jobs competing with the general candidates.

- There have been quite a few new additions of coveted organi-sations who visited the campus this year for the first time and selected students in good numbers. Almost all organisations, including Madura Coats, HMM, Cadburys and Godrej Soaps made final offers in campus itself. Names of the organisations are given in Annexure X.
- Students with work-experience were able to get good offers commensurate with their qualifications. The highest offer was for a job with a salary of Rs.90,480/- per annum. This year there were as many as 44 students with work experience and all of them found jobs matching their expectations. However, it should be noted that they were offered better terms and conditions only in cases where the recruiting organisations felt that their experience was relevant. There had been an increase in the starting salary over the last year and the average salary this year was Rs.4403/- as compared to the average salary of Rs.3526/- in 1989. (see Annexure VIII for details.)
- The problem of having to make selections out of a small number of students was as acute as ever and was faced by the companies coming towards the end of the programme. Detailed communications were maintained with companies to keep them abreast of the number of candidates still available and they were given the option of calling students to their offices.
- The functional areawise, sectorwise and industrywise classifi-cation of job offers made to students in 1990 is given in Annexure IX.
- Summer Placement this year was also extremely satisfactory. 155 students (including a Fellowship student) participated in this programme and despite the large size of the batch, all the students were placed without any difficulty. Students accepted offers from as many as 47 organisations. The projects offered were quite relevant and meaningful in term of Summer Training objectives.

A.1.(13) Extra Curricular Activities

Excellent opportunities for extra curricular development form an important part of the traditions and facilities of the institute. The students run extra curricular clubs in photography, hiking, investment simulation, film appreciation and sports. Football, Basketball, Tennis, Cricket, Hockey, Badminton, Carrom, Table Tennis, Chess and Bridge are regularly played on Campus. In literary and cultural activities, the students participate in various national competitions in debates, quizzes, music and other related activities. As a part of tradition, the Institute annually conducts a QDM (Quiz, Debate and Music) cultural festival in Calcutta which was held in November '89. Several colleges from Calcutta, IIM Bangalore and XLRI participated. As in the previous year, the students hosted a National Business School Meet this year also (in February '90) at which 9 top Business Schools of the country participated.

A.1.(14) Alumni Association

The Association consists of the Institute's alumni passing out of the Post-Graduate Programme and the Fellow Programme as well as the Executive Development Programmes and the Extension Programmes. It serves as a meeting forum for them to keep in touch with each other and with the Institute. The Association is based in Calcutta and has its chapters in Bombay, Delhi, Bangalore and Madras. Efforts are being made to set up more chapters. The alumni help in course modifications and selection of incoming students.

The students and alumni quite often get together both formally, in seminars and lectures organized in collaboration with each other, as well as informally at the Institute and at the latter's offices.

A.2. FELLOW PROGRAMME

Within few years of conducting the Post-Graduate Programme in Management it became evident that neither training nor education in management sciences and practices can remain effective unless its knowledge base is continuously expanded and enriched mainly through research. There were other compulsions also. The need for analysing the experience of management in the Indian environment was strongly felt and urged by many. There was also a large expansion programme for manage-ment education in the universities and the need for competent faculty was growing.

All these compulsions continue to exist even to this day. Meanwhile we have had about a decade's experience in running our Doctoral level Programme which is known as the Fellow Programme of the Indian Insti-tute of Management Calcutta. This experience has included a stage of early experimentation, gradual consolidation and a recent review.

We identified our Institute's goals and objectives afresh in the context of the changing environment, two decades after the Institute came into being. We did find that the demand and expectations from a national institute like ours, pioneers in the field of management education, had grown beyond the boundaries of the familiar corporate industrial sector. Management problems of the environment in which corporate industries worked, such as, public systems and other infrastructural systems also demanded attention, and we could no longer confine ourselves within the limits of our initial activities.

In this context we redefined our objectives for the Fellow Programme, re-emphasised the need for our Institute as a parent institute for nurturing young researchers and potential academics in management sciences.

Management sciences are essentially derived through application of techniques of observation, analysis and conceptualisation, from the basic disciplines in the social sciences, quantitative sciences and the behavioural sciences, apart from the applied aspects of management in the functional fields of production, marketing, finance, etc.

This multi-disciplinary content of management sciences is in fact the strength and raison d'etre of IIMC. Therefore, as a result of our review, we have completely restructured our Fellow Programme allowing specia-lisation in all branches of management sciences including the basic disciplines.

We are convinced that the recognition of the basic strength and origin of management sciences is crucial at this stage of development of the study of Management of India. We hope our new curricula will attract and interest the right kind of student.

Our primary aim is to encourage a whole generation of academics in the field, but it is also a benefit to industry and the Government, at corporate and policy-making levels, where expertise of a type which combines a perception of the broader linkages along with an intimate knowledge of functions at the operational level is necessary.

The Fellow Programme is now in its twentieth year and making steady progress. From the year 1980, the Fellow Programme has been offering opportunities for specialization in Management and in various related disciplines.

At present there are 13 students who are at various phases of their course-work/rewearch in the Programme.

As of now 43 students have been awarded the title "Fellow of Indian Institute of Management Calcutta". They are all gainfully employed in teaching, research, consultancy and other pursuits. Some have joined foreign universities for further studies.

A.2.(1) Admission

We received 324 applications for admission to the Fellow Programme in 1989-90, A separate test ROIT (Research Orientation Identification Test), was conducted in addition to CAT (Common Admission Test). 265 candidates took the examination. 33 candidates were called for interview on the basis of the test, for final selection. Offers of admission were made to 7 candidates out of which 2 candidates joined the Programme.

For admission to Fellow Programme in the session 1990-91, we received 394 applications (about 20% increase over the last year). 299 candidates took the ROIT and CAT Tests, based on the performance in which 42 candidates have been shortlisted for interviews which would be held in April 1990.

A.2.(2) Programme Objectives

0

The Fellow Programme is a full-time doctoral level programme in different fields of Management as well as in various disciplines and areas related to Management. The objective of the programme is to prepare students for careers in teaching and research in management or in the related disciplines and also for positions requiring continued advanced research and consultancy experience.

- A.2.(2)(i) The Fellow Programme in Management offers specialization in the following areas:
 - (i) Behavioural Sciences
 - (ii) Finance and Control
 - (iii) Management Information Systems
 - (iv) Marketing
 - (v) Operations Management
 - (vi) Personnel Management and Industrial Relations.
- A.2.(2)(ii) Besides Fellow Programme in Management, there are six other Fellow Programmes in pure disciplines related to management, namely:
 - a) Economics
 - b) Mathematics for Management
 - c) Operations Research & System Analysis
 - d) Regional Development
 - e) Sociology
 - f) Statistics

A.2.(3) The Title

The title "Fellow of the Indian Institute of Management Calcutta" is awarded to the students on successful completion of the Programme.

A.2.(4) Ph. D. Recognition

The Fellowship in Management and the Fellowship in the six areas related to Management are recognised as being equivalent to a Ph.D. by the Association of Indian Universities. The Government of India also have recognised the Fellowship in Management of this Institute as equivalent to Ph.D. degree in management of a recognised Indian University.

A.2.(5) Eligibility for Admission

The applicant must possess a post-graduate degree in management or equivalent professional qualification or a post-graduate degree in any other discipline and must have secured at least 55% marks or its equivalent. Graduates in engineering, that is, with B.Tech. or B.E. degree, may also apply, provided they have

secured a first class or its equivalent. All applicants are required to take the Common Admission Test (CAT) of the Indian Institutes of Management and a Research Orientation Identification Test(ROIT). Announcement of the procedure for appearing in the Common Admission Test and ROIT is made in leading newspapers in September every year for admission into the programme beginning in July, the next year.

Those who qualify in the CAT and ROIT and who meet the eligibi-lity criteria set above are called for interview around the middle of April. Candidates are first interviewed by the faculty of the area to which they are applying. Those who qualify in the first round are then interviewed by the Fellow Programme (FP) Committee which makes the final selection. Applicants are informed of the decision around the last week of April. A PGDM holder of any of the Indian Institutes of Management, who wishes to enter the Fellow Programme, need not take the CAT, but he/she must take the ROIT if his/her cumulative grade point average (CGPA) is 6.00 and above or its equivalent. If his/her CGPA is less than 6.00 he should take the written test and go through the admission procedure like any other candidate. Graduates of the four IIMs applying for the Fellow Programme in Management (FPM), who have a CGPA of 6.00 and above (or its equi-valent) are also automatically eligible for direct admission to the 2nd year of the Fellow Programme. Applicants with the equivalent of a PGDM from any of the universities with a CGPA of 6.00 or equivalent, may request direct admission to the second year and this may be granted at the discretion of the Fellow Programme Committee. Students with a Master's degree or more, in any of the pure discipline areas, can also be admitted directly to the 2nd year of Fellow Programme in that area.

A.2.(6) Outline of the Programme

The programme consists of course work followed by a dissertation. The course work phase is of two years duration covering six terms. A waiver may be granted from the first year to suitably qualified candidates. On satisfactory completion of course work, a Comprehensive Qualifying Examination (CQE) is held. After qualifying in the CQE, the student is required to submit his dissertation proposal to an interdisciplinary Thesis Advisory Committee consisting of a thesis supervisor and two other faculty members. The student finally defends his dissertation before a Thesis Evaluation Committee.

A.2.(7) **Duration of the Programme**

The normal duration of the programme is four years for those who enter the first year and three years for those who enter in the second year. Two years are spent on course work and two years on dissertation. Students who join in the second year spend only one year on course work. For various reasons some students require more than two years to complete the dissertation. Students are therefore allowed to continue upto four years after course work, upon reports of satisfactory progress from the Thesis Adviser. However, there is a time limit of eight years for the completion from the year of entry beyond which only under very exceptional circumsances will a student be allowed extension. Every student admitted to the Fellow Programme is placed under the guidance of an Academic Adviser to help him to organize his academic programme, specially in the selection of optional courses during the first two years.

A.2.(8) <u>Fees</u>

No tuition fee is charged. However, the charges for Hostel Room rent @Rs. 200/- per Term, Students' Association fee of Rs.80/- per year and Registration fee @ Rs.100/- per year, are compulsory. A caution deposit of Rs.400/-, which is refundable under certain conditions after completion of the programme, is payable by the student on acceptance of the offer of admission.

A student who prefers to drop out voluntarily from the programme or is required to leave the Programme under F.P. rules will forfeit his caution Deposit.

In addition, a dissertation fee of Rs.200/- is payable at the time of submission of the dissertation.

A.2.(9) Financial Aid

A student is awarded a scholarship, which ranges from Rs.1800 to Rs.2500 per month. In addition there is a contingency grant of Rs.3700 per year payable under the rules of the Fellow Programme. If the student's research work in connection with the dissertation involves extended field work and hence substantial expenditure not covered by the contingency, ad-hoc research grants are awarded depending on merit of the case.

The rates of scholarships are as follows:

Students with M.B.A., M.E., M.Tech., and M.Phil or B.Tech., B.E., M.A., M.Sc., or M.Stat., with two years work experience are awarded Rs.2400/-per month for the first two years and Rs.2500/- per month for the subsequent years.

Students with B.E., B.Tech., M.A., M.Sc., and M.Stat., with less than two years work experience are paid Rs.1800/- per month for the first two years and then Rs.2100/- per month for subsequent years. A student normally gets 4 years scholarship and contingency fund. A student can also have an extension for a period of one year at the end of 4 years on the basis of his research ability recommended by the Institute, for completion of the programme.

A.2.(10) Residence

Students are generally required to stay on the Campus for which hostel accommodation is provided. The Institute has no arrangement of housing accommodation for married students with their spouses.

A.2.(11) Placement

Placement facilities are available to all Fellow students who have successfully completed the Programme requirements.

The Institute encourages Fellow students to take up assignments which offer opportunities for research.

A.2.(12) Summer Project

Between April and June of the first year, students who are promoted to the second year are provided with two options:

a) To work on a specific management problem in a private or public sector organisation under the guidance of a faculty member. Permission to do this is granted by the Fellow-Chairman on the recommendation of his Faculty Adviser. The summer project should be directly related to the students' area of specialization.

Or

b) To undertake research work relevant to his area of specialization. This should be done in consultation with the Faculty Adviser and the student must inform the Fellowship Chairman accordingly.

A.2.(13) The Comprehensive Qualifying Examination

The Comprehensive Qualifying Examination(CQE) consists of a written examination in two parts covering the candidate's major and minor areas and is followed by an oral examination. If any student leaves the Institute before completing the CQE and Thesis proposal defence, he will not be allowed to continue in the Programme.

A.2.(14) Evaluation of Thesis Proposal

On successful completion of the Comprehensive Qualifying Examination (both written and oral) the students are allowed to start work on their thesis. The thesis proposal will have to be evaluated and approved by the student's Thesis Advisory Committee which will forward its recommendation to the Fellowship Committee.

A.2.(15) Thesis Examination Committee

The thesis is to be evaluated by the members of a Thesis Examination Committee consisting of two internal and two external examiners.

Unanimous acceptance of the thesis by 4 thesis examiners is required. If the thesis is rejected by more than one examiner, then the thesis has to be resubmitted. If the thesis is rejected by only one examiner, then the opinion of a fifth examiner will be sought whose decision will be final.

The student can resubmit his thesis only once. After unanimous acceptance by the examiners through comprehensive reports, there will be a public defence of the thesis in presence of the Thesis Examination Committee and other faculty members and interested persons.

Two students who completed all the requirements were awarded the title "Fellow of IIMC" during the year 1989-90.

A.3. POST-GRADUATE CERTIFICATE COURSE IN GENERAL MANAGEMENT (PGCGM)

Responding to the ever increasing demand for a well-designed comprehensive programme in Management from practising managers in the city of Calcutta and around, IIMC started a Two-Year Evening Programme leading to the Post Graduate Certificate in General Management in 1981. Classes are held thrice a week on alternate days from 6 p.m. - 9 p.m at the Institute's city office at 8,Ho-Chi-Minh Sarani, Calcutta 700 071. It is a non-residential course.

In designing and implementing this Programme, attempts have been made to combine the experience based strength of the participants with the conceptual rigour of inputs drawn from a comprehensive set of management disciplines. The focus has consistently been to develop such knowledge, skills and perspectives which will enable these candidates to become effective managers and be prepared to assume higher responsibilities. Based on the experience of the seven successive batches of students, the project work has been made more rigorous and allowed for a greater flexibility for the participant to plan his courses given the typical constraints he faces as a working executive.

During the year 1989-90, there were 57 students in PGCGM First Year (9th Batch) and 38 students of the 8th batch (1988-90) and 3 students of the 7th batch (1987-89), in all 41 students in the PGCGM Second Year. Based on the performance till the end of 7th term, it is expected that all the 41 students now in the second year would qualify to be awarded the "Post-Graduate Certificate in General Management" in April 1990. One student of the 1988-90, (8th batch) has ben permitted to repeat with 1989-91 (9th batch) of students to complete the requirements.

For selection of the 10th batch (1990-92) of PGCGM students, an admission test was held. A total of 470 applications were received and 288 candidates sat for the written test. Out of these, a total of 96 candidates were shortlisted for interview. Sixtyfour candidates were offered admission in PGCGM out of which 58 joined finally.

A.3.(1) Programme Curriculum

In all, twentyone courses and a project (equivalent to one course load) based on a problem pertaining to the organisation in which the candidate is working, comprise the curriculum. A proposal for the project would need approval of the faculty in the area in which the work is intended to be done. The termwise break-up of courses offered is given below:

The candidates are normally required to take all the courses offered in the sequence as outlined above. However, they have the option of spreading these over a period not exceeding three years subject to the condition that such option may be exercised only after completion of the first three terms.

A.3.(2) Eligibility for Admission

The candidates for admission to the Programme should satisfy the following criteria:

(i) The applicant must hold at least a Bachelor's degree in any discipline or a professional qualification recognised as equivalent to a Bachelor's degree by the Department of Education, Government of India.

- (ii) The applicant should be employed at the time of applying for admission to the Programme.
- (iii) The applicant should have held Executive/Supervisory position in Business/Industry/ Government for a minimum period of two years after graduation.

The eligible candidates are required to appear at an admission test and are selected for the Programme based on the following factors:

- (i) Scores secured in the Written Test
- (ii) Previous academic record of the candidate
- (iii) Work experience
- (iv) Aptitude, ability and interest to pursue management studies as revealed in the interview.

A.3.(3) <u>Fees</u>

A fee of Rs. 1,400/- per term per participant is charged for the first six terms.

A.3.(4) Extension Programmes

Extension Programmes generally aim at imparting basic managerial concepts and skills with a view to improving the participants' effectiveness in their functional areas.

During 1989-90, one Extension Programme on General Management was offered in which there were 21 participants.

B. TRAINING PROGRAMMES

An important objective of the Institute is to provide practising managers and administrators at different levels in industry and government an opportunity to equip themselves with knowledge in the field of management, to improve the problem-solving ability and to develop their decision-making skills and managerial competence. The Institute, therefore, conducts a wide variety of training programmes which include executive and management development programmes, workshops, seminars and conferences as well as programmes sponsored by various Departments and Agencies of the Central and State Governments, local governing bodies and organizations both in the public sector and in the private sector. All these training programmes can be classified broadly into two categories:

I. Management Development Programmes (MDPs), [called earlier as Executive Development Programmes (EDPs)] are initiated by the Institute itself and offered to practising managers and administrators on intercompany basis as a means for continuing education in the field of management. MDPs are not designed for a

specific organization per se; they are, by and large, given a somewhat broad focus so that executives from more than one organization can participate meaningfully in such programmes. A few of these programmes are offered in collaboration with other organizations such as professional societies and government agencies.

II. Sponsored Training Programmes, which are organized by the Institute in response to request from client organizations to conduct such programmes. Most of these programmes are designed specifically to suit the training requirements of individual organizations.

B.1. Management Development Programme

During the year under review 15 Programmes were held with a total number of 290 participants. A list of the Programmes held is shown in Annexure XI.

B.2. In-Company Training Programme

Twenty-three In-Company Training Programmes were held during the year 1989-90 (Annexure XI).

B.3. Training Programmes Sponsored by Government

During the year under review 10 Government Sponsored Training Programmes for IAS officers were conducted by the Institute. There were a total of 228 participants (Annexure XII).

B.4. Advance Management Programme

The Institute conducted the Thirteenth Advanced Management Programme (AMP) for senior managers of the public enterprises, sponsored by the Bureau of Public Enterprises, during the year. The directing staff were Professor Ramaswamy P. Aiyar, Director, IIM Calcutta, Professor K. K. Bhattachrya of the Finance and Control Group and Professor M. N. Pal of the Operations Management Group of the Institute. There were 30 nominations, out of which 28 participated in the programme.

The Programme was of 4 weeks duration from the 8th May, 1989 to the 2nd June, 1989, which was followed by a week's study tour to Italy from the 5th to 11th November, 1989, with an itinerary involving visits to the three major holding companies in that country.

The Programme was designed with a general management orientation with special emphasis at corporate level, policy making issues and decision areas. The programme also laid stress on the role of computers as support for Management Information Systems and development of decision support systems.

While the programme at the Institute provided to the participants meaningful and participative learning opportunities, the study tour to Italy provided to them ample opportunities to interact with a wide cross section of policy makers and senior managers of public systems.

C. RESEARCH

Centre for Management and Development Studies:

The Centre for Management and Development Studies (CMDS) plays a coordinating role in the promotion of research activities at the Institute. Apart from sponsoring research projects, the CMDS also finances seminars, workshops and can provide seed-money for externally sponsored/funded research projects channelled through the Institute.

During 1989-90, 10 new research projects have been undertaken by the members of faculty and research staff with the CMDS support. The list is given in Annexure XIII.

Five projects have been completed during the year. A list of completed research projects during 1989-90 is given in Annexure XIV. At the end of 1989-90, there were 23 on-going research projects, details of which are given in Annexure XIVA.

Researches funded by CMDS may broadly be classified into

- Basic research, and
- empirical/field studies

A brief description of the research projects sanctioned during the year is given below:

C.1(1) Residual Life Function and its Properties: Prof. Chandan K. Mustafi

The idea of residual life is of interest in biometry, actuarial studies, reliability management and social sciences. Given that a particular phenomenon has been observed to survive upto a certain time, a study of the remaining life will be made in the proposed research. The study will be focussed on the stochastic processes generated from the estimated parameters of the residual life distribution, thereby extending the studies published earlier. The duration of the project is from 1.4.89 to 30.6.90.

C.1(2) <u>Determinants of Contract outcome</u>:

<u>A Profit Analysis of negotiated settlements in India</u>: Prof. Debashish Bhattacharya

The nature, scope and coverage of the collective bargaining agreement in the India Urban Labour Relations System have undergone considerable change during the last decade. Specifically, a conroversy exists in the contemporary literature as to whether the state has increased or decreased its intervention in the determination of collective bargaining outcomes. It becomes theoretically and empirically important to specify factors that either increase or decrease the probability of state intervention during contract negotiations. These questions are also relevant to policy makers of Government, Industry and Labour. The research aims to achieve this objective. The duration of the project is one year from 1.4.89.

C.1(3) <u>Identity and Coping Strategy - The dilemma of Working</u> Women: Prof. Leena Chatterjee

In the course of a little more than the past one decade, a number of books, articles and research studies have dealt with the theme of the role of Working Women and their impact on Indian Society. Most of the writings have examined and analysed the issue from a Sociological perspective. Such studies have contributed greatly to our understanding of the external pressures that Working Women face in taking up various roles that often come in conflict with one another e.g. the role of a wife/mother and the work role. The aim of the proposed research is to build on some of the important issues raised in these articles and to examine the psychological impact these pressures have on the psyche and Coping Styles of Working Women. The duration of the project is 3 years from April, 1989 to March, 1992.

C.1(4) Patterns of Industrialisation: Prof. N. K. Chandra

This Research Project is in continuation of the earlier Research Project on "Trade Industrialisation and Agrarian Changes" which had already been completed. The basic idea is to explore different aspects of inter-related changes in Agriculture, Industry and Foreign Trade in the initial phases of industrialisation in countries with alternative Socio-economic systems. For the purpose of this project, attention would be confined to India, USSR, China, Japan and the two Koreas. The duration of the Project is 3 years from 1.9.89.

C.1(5) Development of efficient algorithms for problem involving variable upper bounds: Prof. Nilotpal Chakraborty

The Project aims at designing efficient algorithms for solving optimisation problems involving variable upper bounds. The problems arise in a great variety of application areas. The project may lead to the development of Software to implement these algorithms. Even though the project is primarily theoretical in nature, it is likely to lead to results of significant practical importance. The duration of the project is one year from 1.11.89.

C.1(6) Basic assumption of Managers: A determinant of Managerial behaviour: Prof. B. N. Srivastava

This project aims at developing a theoretical model of integrating the concepts of basic assumptions about nature of man as a determinant of managerial behaviour by identifying the various correlates and empirically testing their relationship.

C.1(7) The Macro-economics of contesting political ideologies: Prof. Amit Bhaduri

It intends to make use of macro-economic analysis as basis for understanding different economic policy postures and ideologies. The project will examine the situation obtaining in advanced capitalist countries, in the first phase, to be followed

by examination of the issue concerning socio-democracy and then to the situations related to under-developed capitalism.

C.1(8) Industrialisation: Landscape change and unequal development: The case of the Maharashtra Industrial Development Corporation: Prof. Annapurna Shaw

The purpose of the study is to analyze the role of the Maharashtra Industrial Development Corporation as an agent of landscape change and economic/social transformation within Maharashtra.

C.1(9) Unions and the Politics of Production in Western India: Prof. Debashis Bhattacharya

The objective of this project is to examine the relationship between the processes to unionisation, labour markets and bargaining in Western India. It will also examine how these processes had been seen by citizens in urban Maharashtra.

C.1(10) Foreign Collaboration in the India State Industrial Sector: Prof. Nirmal K. Chandra & Shri Bernard D'Mello

The objectives of the project are (i) an analysis of the nature, scope and effect of foreign collaboration in the Public Industrial Sector including the experiences of local R&D design and engineering etc. of building an indigenous technological capability by import substituting technology and (ii) a comparative study of technological development in the Chinese, Indian and South Korean Steel Industries (1953-85).

C.2 Centre for Rural Development Management Programmes:

- C.2(1) During the year 2 volumes (mimeo) of "Directory of Organizations in Rural Development" and Three volumes of "Selected Bibliography on Rural Development Management" have been compiled.
- C.2(2) Two Volumes of Selected Bibliography on Rural Development Management (based on mimeo volumes V to IX and X to XIII with 13630 entries) have been processed for printing and are expected to be out soon.
- C.2(3) One week Training Programme on Management of Rural Development for Executives of Voluntary Organizations was held during July 10-16, 1989 in Calcutta with 32 participants from 8 States.
- C.2(4) Two Training Programmes of One Week's duration for 38 Chief Executives of Lutheran World Service from Nepal, Bangladesh and India on Management of Rural Development Programmes were held at Calcutta during September 11-16, 1989 and February 19-24, 1990.
- C.2(5) Three meetings of Rural Development Standing Committee were held in August, October and December 1989, at Calcutta.
- C.2(6) Research project sponsored by ICOMP on Community Participation in health and population A case study of CINI, is on-going and is expected to be completed soon.

- C.2(7) A study on Role of Voluntary Organizations in Rural Development in the eastern region states has been initiated and the field work is planned to be conducted during July-December, 1990.
- C.2(8) It is proposed to conduct three one-week Training Programmes on Management of Rural Health Services during June 1990 at Joka Campus for 105 District and State level Officers of the Department of Health & Family Welfare, Govt. of West Bengal and Govt of Orissa.
- C.2(9) It is proposed to conduct three one-week Training Programme on Management of Rural Health Services during July 16 and August 20, 1990 for 105 medical officers from IPP IV districts in West Bengal at Harrington Mansion.
- C.2(10) The Research proposals on Rural Poverty and Development (IRDC, Canada) and Distance Learning for District level health officials in India (WHO, Geneva) are expected to be cleared soon and these two projects would be initiated during 1990-91.

Besides, inputs from different activities under RDMP have been used in offering PGP/FP courses in the Institute, Training Programmes, Seminars and Workshops conducted and participated by Faculty and Research Staff. We have also assisted a number of Voluntary Organizations (Regional, National and International), Planning Commission, Technology Missions, State Planning Board, State Research Institutes, Universities, Chambers of Commerce, State Govt. Departments, Corporations and other development agencies, Rural Financial Institutes in providing information supports training/course materials, guidance in Project Planning, monitoring and evaluation and other management inputs for effective implementation of different programmes and specific projects.

C.3. Centre for Studies in Public Enterprises Management

- C.3(1) The Board of Governors of this Institute has identified public enterprise as a key research area. To promote research and training in this key area of national importance a Centre for Studies in Public Enterprises Management has been set up.
- C.3(2) In 1989-90 the Centre played a major role in helping the Government shape its current policy towards public enterprises. It worked actively with the Bureau of Public Enterprise in designing and implementing Government's policy of MOU between public enterprise and Government. The Centre was involved in several research projects, training programmes and workshops dealing with public enterprise management and policy. The major objective of this work is to ultimately improve the efficiency of Indian Public Sector. By most accounts, the Centre has made a great deal of progress towards this goal. According to one estimate, if all these efforts can improve the efficiency of public sector even by 5%, the benefit to the national exchequer would be approximately Rs. 3,000 crores.
- C.3(3) A Committee of Secretaries to the Government of India headed by the Cabinet Secretary has accorded the Centre a nodal role in research and training relating to MOUs.

C.3(4) In 1990-91, the Centre will continue its efforts by undertaking the necessary research, training and seminars to sustain this momentum.

C.4. Centre for Project Management

The Centre for Project Management has been set up to carry out research and conduct training programmes in the area of project management with a focus on the following themes:

- Issues related to project implementation in India.
- * Long-term and short-term guidelines on the policy as well as procedures to be adopted for effective implementation of projects from conception to commissioning.

D. CONSULTANCY

Besides the on-going consultancy assignments undertaken for public and private sector organizations, a number of new consultancy assignments were taken up by the Institute on behalf of different organizations - both in the public as well as in the private sector. The demand for the Institute's consultancy services has been increasing. Consultancy requests are also coming from non-conventional sectors.

A list of the consultancy assignments initiated by the Institute during the year is shown in Annexure - XV.

E. PUBLICATIONS

JOURNAL

DECISION, the Institute's quarterly journal containing articles on management thought, research and practice, continued to be published during the year 1989-90. The journal has stepped in its sixteenth year of publication.

Three issues of DECISION, viz. Vol.16, No.2, April-June, 1989, No.3, July-September, 1989, No.4, October-December, 1989 have been published and another issue of Vol.17, No.1, January-March, 1990 will be coming out very soon. The above mentioned issues contained 21 articles and 8 books Reviews. Most of the articles were from external contributors. Some of the authors were from Universities abroad. Most of the Book Reviews have been contributed by the internal members of faculty. A special number on "Public Enterprise Management" combining Nos. 2&3, Vol.17, April-September, 1990 is under preparation.

We are getting a good number of subscribers to DECISION through the process of distribution to the respective participants of Management Development Programmes. This being a priced publication, the costs involved in distributing the journal to individual participants are credited to our Publication's Accounts debiting the concerned Programmes. The recently introduced practice of advertising

DECISION in Economic and Political Weekly haw also resulted in an increase in subscription.

The exchange programme of advertisement with <u>Labour and Society</u> (Journal of International Institute of Labour Studies, Geneva), <u>IIMB Management Review</u>, Indian Institute of Management Bangalore and <u>Vikalpa</u> (Journal of Indian Institute of Management Ahmedabad) continued during the year.

WORKING PAPERS

During the year under review 18 Working Papers by the Members of Faculty/Research Staff have been published. We have also been able to maintain an exchange programme of Working Papers with reputed Insti-tutes/Universities both in India and abroad. At present this Division brings out about 200 copies of each Working paper and in turn, Institutes/Orga-nizations under exchange programme are sending their Working Papers to us. In this process the WPS get a wider circulation.

BOOKS

We are in the process of bringing out Bibliography (Vol.II) on Management of Rural Development by Prof. Madhu S. Mishra. We shall also start work very soon with regard to bringing out Directory of Organisations in Rural Development (Vol.IV) by prof. Madhu S. Mishra.

4. ANNUAL CONVOCATION

The twenty-fourth Annual Convocation of the Institute was held on 29th April, 1989. Hon'ble Vice-President of India, Dr. Shankar Dayal Sharma, was the Chief Guest. Dr. P. K. Basu, Chairman of the Board of Governors of IIMC, presided over the function.

147 students of the Post-Graduate Programme were awarded the Post-Graduate Diploma in Management. There were 139 boys and 8 girls amongst the graduating students. A list of the graduating students is appended in Annexure XVII.

Four Fellow students of the Institute were awarded the title 'Fellow of IIMC' at the Convocation. A list of the students along with their dissertation titles is shown in Annexure XVIII.

5. COMPUTER AIDED MANAGEMENT (CAM) CENTRE

The Computer Aided Management (CAM) Centre was established in March 1984 with funds from the Department of Electronics (DoE), Government of India, and the United Nations Development Programme (UNDP), with the objective of promoting the development of applications software in India in the area of Industry-Oriented Management Techniques. Infrastructural facilities, such as office space and administrative manpower were provided by IIMC. The CAM Centre has a team of

experienced computer professionals whose primary responsibility is to develop project software for industrial applications; they also participate in teaching and research. They are helped and guided in their work by the faculty members belonging to the Management Information Systems (MIS) Group of IIMC. The technical and administrative activities of the Centre are supervised by a project Coordinator, who is a senior member of the IIMC faculty.

Computing resources located at the Centre include a VAX 11/750 Supermini Computer with 14 terminals, some having colour monitors and high resolution graphics capabilities; a cluster of six SUN workstations, some supporting colour graphics; 11 PC/XT and one PC/AT; and a desk top publishing system equipped with a laser printer that belongs to the Publications Section of IIMC. Very recently a Local Area Network (LAN) has been installed which connects about 50 PCs located all over the campus. A PC Room on the first floor with 10 LAN-connected PCs has recently been opened to users.

The CAM Centre Library has an extensive collection of books and journals on Computers and Information Systems. The Centre also has a class room that can accommodate around 30 persons; this room has been provided with a PC and a video projection system.

The Centre has been successful to a great extent in fulfilling its objective of developing decision support software for the Indian public sector industry. The List of clients includes Indian Oil Corporation, Bharat Pumps and Compressors, Survey of India, etc. Some of the software developed by the Centre are already in daily use. UNDP assistance to the CAM Project terminated on December 31, 1988; the DoE is continuing its support till March 1991.

During the year under review a number of eminent scholars visited the Centre. Prof. Dana S. Nau of the University of Maryland, U.S.A., gave a series of lectures on the applications of Artificial Intelligence to Computer Aided Design and Manufacturing; Prof. Sukumar Ghosh of the University of IOWA, U.S.A., gave a talk on Self-Stabilizing Distributed Computer Systems. In addition, a series of seminars by Sri P.S. Dasgupta, Systems Analyst, on Logic in Artificial Intelligence, was initiated; these seminars are still continuing. Sri Subir Bhattacharya, Senior Systems Analyst, was awarded a three-month Fellowship by UNDP in October 1989 to work in a research project at the Department of Computer Science, University of Minnesota, under the guidance of Prof. Vipin Kumar. He subsequently submitted his Ph.D. thesis to the University of Calcutta and joined the MIS Group as an Assistant Professor. Prof. Amitava Bagchi presented two papers at the International Joint Conference on Artificial Intelligence (IJCAI-89) at Detroit, U.S.A. during August 1989. On February 24, 1990 a national seminar on the CAM Project was organized at IIM Ahmedabad where representatives of the Centre made presentations on the projects.

7. LIBRARY

The B.C. Roy Memorial Library is now looked upon as an integral part of our national resources of learning in the field of management and allied disciplines. During the year an addition of 5025 books/bound periodicals has been made to its stock of over 1 lakh of such volumes. The library boasts of a rich collection of micro documents including pamphlets, reports and monographs apart from its special collection of Corporate Reports, Serials, Government Publications, microforms and films. About 750 periodicals are being subscribed to currently.

The Library has a Central air conditioning system and has its inhouse reprographic facility to support readers' service.

During the year, the Library has further strengthened its audio-visual resources by procuring educational films and video cassettes. The Auditorium of the Library which is also air conditioned under the centrally air conditioned system has been equipped with seating accommodation for 100 viewers.

8. CAMPUS DEVELOPMENT

The following works have been completed during the year 1989-90:

- a) Construction of 2 rooms on either side of the front portion of the Ramanujan Hall, Central Block, each measuring 5m x 6m.
- b) Improvement of toilets in the remaining 43 rooms in the MDP Hostel. The work of improvement in the 19 rooms taken up last year was also completed.

- c) External electrification along the boundary of the campus. Work of filling for land development spilled over from 1988-89.
- d) Concrete piling work for the three major buildings i.e. Teaching Block for 50 faculty members, Hostel Building for 170 Students and Kitchen Staff quarters for 48 members. The super structure of the above three buildings is in progress. The work is undertaken under the supervision of M/s. Rites-Sengupta Associates.

Besides the above, repairs and maintenance of buildings, roads, water mains and electrical installations (including air conditioning and refrigeration equipments) inside the campus and maintenance of city hired flats, were undertaken round the year.

16. FUTURE PLAN

During the last Five-Year Plan it was proposed to establish an International Management Education Centre for students of developing countries which we hope will be cleared soon by the Government. The Institute is also involved in the UNDP Project on International Management Education. This project is basically aimed at building expertise in the area of International Management in 4 Indian Institutions which include IIMC. This project is already under way and by 1991, many faculty members, who have expressed interest in this project would have visited a number of business schools in US, Europe, Japan and North America and many experts from these countries would have visited IIMC to participate in seminars and workshops, etc.

The Government has approved a programme of Cooperation and Exchange between the Management Training Institutions in India and similar Institutions in EEC countries. A Memorandum of Understanding was concluded during the year between the Government of India and the European Commission for this purpose.

The objective of the programme is to develop a faculty group with thorough knowledge and experience of the management education system in EEC countries and of management methods and practices in European companies. The aim is to develop lasting institutional links in management education.

It provides for visit of 20 Indian participants (upto 10 each year) for the aggregate duration of 180 man months. The programme is essentially for a period of 2 years, but is likely to be extended.

IIM Calcutta is one of the 7 Institutions participating in this programme. The European Institutions involved are -

- i) Bielefeld University, Bielefeld, Federal Republic of Germany.
- ii) ESSADE, Barcelona, Spain.
- iii) INSEAD, Fountaineblean or ESSEC, Cergy-Pontoise, France.
- iv) K. U. Leuven, Belgium.
- v) London Business School, U.K.
- vi) Rotterdam School of Management, Erasmus University, The Netherlands.
- vii) SDA Bocconi University, Mllan, Italy.

The first batch of Indian participants under the programme, which left for the European Institutions during the year, included two faculty members of this Institute.

For the Eighth Five-Year Plan the Institute has expressed interest in working in the following areas:

- 1. Management of Cooperatives
- 2. Management of Population Problems
- 3. Management of Health and Nutrition
- 4. International Management
- 5. Policy Research
- 6. Technology Management including Manufacturing systems.

Another area which is important is the development of values. IIMC has already done considerable work and many training programmes conducted by the Institute cover issues of HRD which have emerged from the work of Indian scholars and philosophers.

The problems of women and weaker sections merit attention and a group at the Institute proposes to take this up during the next plan period.

However, on the basis of what is indicated in the Eighth Five-Year Plan documents, IIMC will choose one or two of the above areas for emphasis. The major contribution of IIMC in the above mentioned areas will be in training and research.
