The 5 other articles are selected from an array of several submitted papers for the Conference. The authors include Huma Akram from Northeast Normal University of China, describing different sources of psychological stress factors of students particularly in the post-pandemic era and their plausible solutions; Devi Priya of IIM Calcutta who focuses on the stress factors and low level of job satisfaction of Indian school teachers due to digital labour; Kumari Vibhuti Nayak from Centre for Studies in Social Sciences who discusses the plights faced by girls from the marginalized communities due to this digital division reinforced due to pandemic; Kedarnath Thakur from XLRI School of Management talks about association between the pedagogical changes due to the virtual mode of learning and learning outcome of management students, and finally, the article by Rohit Kumar Nag from IIM Calcutta explores the shortcomings of infrastructural areas in Indian education system to make use of EdTech in an efficient, accessible, affordable and inclusive way.
